


Two thousand eighteen was a big year for the Rental Assistance Demonstration Program (RAD) at the Greensboro Housing Authority (GHA). As a reminder, RAD is a program of the U.S. Department of Housing and Urban Development (HUD) that seeks to preserve aging public housing communities by providing additional funding to make physical improvements. GHA was approved for the RAD program in December of 2013, and it has helped us make much-needed upgrades to our properties.

Two thousand seventeen ended with the conversion of nine properties (645 public housing units) to the Section 8 Project-Based Voucher program. With the conversion, GHA was able to obtain financing to perform improvements on the properties, some of which were new roofs, flooring, painting, appliances, and HVAC systems. By December 31, 2018, GHA reached the goal of substantial completion of six properties (495 units) — Lakespring, Ray Warren, Applewood, Pear Leaf, Laurel Oaks, and Woodberry Run/Baylor Court. GHA thanks the residents for their patience and help in reaching this momentous goal!

Substantial completion means that all scope of work items were installed; however, it does still mean that there are details to finish and remaining clean up work. Please be aware of crews around your property and be prepared as these last few updates are completed.

The next communities that will see improvements are Silverbriar, River Birch and Stoneridge, which will be completed in 2019.

Inclement Weather Reminders

Remember!

With winter upon us, and having already experienced some snow and ice this season, below is GHA's policy for handling winter weather precipitation:

- Upon snow or ice forecast, designated elderly and sites with a shared egress will be treated with ice melt and/or sand to improve traction. Mechanical and manual snow removal will be initiated once the snow event has finished.
- Upon snow or ice forecast, all common access facilities including Management Offices, and Community Buildings will be treated with ice melt and/or sand. Upon snow fall or ground icing, the same areas will be cleared and de-iced to improve traction.
- Upon the commencement and/or accumulation of ice, snow and like kind of precipitation, GHA Staff and/or contractor support staff will be dispatched to address initial remediation activities. Staff will continuously monitor sites for hazardous conditions in the following days to reduce safety issues.

Here are some tips for dealing with winter weather:

- **Prepare for an Absence-** Be sure that your heat is set at a minimum of 55 degrees. This will prevent the inside temperature from plummeting into the danger zone.
- **Keep Utilities On-** Damage caused by frozen pipes in an unheated apartment will result in a serious lease violation and payment for repairs.
- **Turn on Faucets-** (when the weather reaches 32 degrees outside) Let the water run no faster than a slow, constant drip.
- **Open Doors-** Open the cabinet doors in your kitchen and bathroom(s) to allow heat to reach the pipes.

In addition to work at the remaining scattered sites, there will also be work performed at Foxworth and Woodland Village.

GHA plans on having resident meetings across the sites to discuss the impact of construction. To have the most up to date information, please plan on attending the session at your site.

As a reminder, GHA will provide boxes, tape and bubble wrap for those experiencing renovations. Once your unit is completed, and items are unpacked, please remember to break down all boxes and dispose of them in the dumpster. For those who are still undergoing renovations, pack your valuables, fragile and sentimental items, and clearly mark them. You are welcome to move them yourself or take them elsewhere if you choose. Not being prepared could result in a longer construction time.

A tip to make the process easier is to prepare meals in advance that can be warmed up quickly in the microwave or oven so that you don't have to attempt cooking full meals in the kitchen during renovation. Disposable plates, plastic ware and cups also helps make preparing food at home easier.
